This certificate covers conditioning agent with the brand name 'Akdolit® Hydro-Calcit C G'.

PRODUCT REQUIREMENTS

The products as described in this certificate comply with BRL K15003, including the requirements as specified in: NEN-EN 1018 (CaCO₃) Chemicals used for treatment of water intended for human consumption – calcium carbonate.

FITNESS FOR CONTACT WITH DRINKING WATER
